Digital Community School

Agranee has been facilitating three "Digital Community Schools" in partnership with EMP Bindi International Association, Ajmer, Rajasthan aiming at provide digital education through applying modern technology for rural minds. Mostly out of school, dropout, irregular and working children belong to tribal communities are being provided free education during their leisure hours (evening) in all three centers located at village Dilisar & Gadasahi under Ranipokhar GP and Dukesahi under Dewanbahali GPs of Kaptipada Block Mayurbhanj, Odisha. Apart from traditional TLM digital teaching learning materials like- Solar power run Projector and I Pads have been provided to the centres including adequate training to staff, teachers and parents. A total of 81 students from deprived tribal families continuing their studies in all three centers that includes both girls & boys.

Solar Electrification for Domestic Lighting

Like previous year this year also Agranee managed to install 100 decentralized solar home lighting systems of 75 watts along with 15 solar street lights covering two non-grid villages/hamlets namely Jharjhari and Khumudihasahi of Thakurmunda block Mayurbhanj, Odisha in collaboration with EMP Bindi International Association, Ajmer Rajasthan. Also one solar power packed Rural Energy Workshop (REW) installed at village Khumudihasahi where repair & maintenance of installed solar domestic systems done with providing necessary spare parts when & where required by the trained solar Mamas.

Training to Women on Financial Literacy "Aage Badhein"

The "Aage Badhein" is an interactive app, which provides opportunities to improve skill in a playful manner through stories, videos, exercises and simulators. This intervention aims to disseminate financial literacy among rural women/ communities through this self-learning tool to increase user's ability to make improved financial decisions by engaging in household budgeting, understanding the importance of regular savings, and reduce the unease associated with using financial services such as an ATM, BHIM, bank accounts etc.

A total of 200 women of Kaptipada block of Mayurbhanj district imparted financial training under "Aage Badhein" during the year as an extension of Enrich programme technically & financially supported by EMP Bindi International Association.

Support to Residential Schools

Two 3kw micro grid solar systems installed in two government run residential primary schools namely Prasanchandrapur & Padmapokhari comes under Kaptipada block of Mayurbhanj district to provide uninterrupted power supply and reduction in electrify bill. Also 50 desks & benches of 200 students sitting capacity along with a large water coller with RO purifier provided to one residential high school at village Pahadpur of Kusumi block during the year with the support of EMP Bindi International Association.

Preparation of Village Disaster Management Plan (VDMP)

Initial field level activities like secondary data collection meeting with village level leaders & functionaries along with line department officials has been completed of all 30 villages during the year. Formation of VDMCs and training of its team members is about to be completed of all 30 VDMPs. Simultaneously preparation final maps and DTP is under process and seems to be completed and submitted to the DDMA Mayurbhanj soon.
