### **Digital Community School**

Agranee has been facilitating three "Digital Community Schools" in partnership with EMP Bindi International Association, Ajmer, Rajasthan aiming at provide digital education through applying modern technology for rural minds. Mostly out of school, dropout, irregular and working children belong to tribal communities are being provided free education during their leisure hours (evening) in all three centers located at village Dilisar & Gadasahi under Ranipokhar GP and Dukesahi under Dewanbahali GPs of Kaptipada Block Mayurbhanj, Odisha. Apart from traditional TLM digital teaching learning materials like- Solar power run Projector and I Pads have been provided to the centres including adequate training to staff, teachers and parents. A total of 92 students from deprived tribal families continuing their studies in all three centers that includes both girls & boys.

### **Beekeeping by Women Farmers**

The overall objective of this initiative was to reduce gender inequality and improve quality of life by supporting poor and marginalized women to earn extra income through sustainable Beekeeping practices and marketing of bee products. Under this programme Agranee has enabled a total of 80 tribal women farmers to earn their livelihoods by providing necessary Bee keeping equipment i.e. bee boxes with bee colony, smoker, face safety mask, hand globes and extractors etc during the financial year. Approximately 150 kg of honey harvested and marked by the farmers at the cost of Rs.400/- per kg in the local market during the year along with their own consumption.

### **Solar Electrification for Domestic Lighting**

Apart from regular operation and maintenance of last year installed 100 families belong to two non-grid villages/hamlets namely Tenda and Purunapani of Kaptipada block Mayurbhanj two new villages have been identified and villagers given consent for installing another 100 solar domestic lighting systems including 15 street lights by the end of F/Y- 2024-25 by Agranee in collaboration with EMP Bindi International Association, Ajmer Rajasthan. Two low literate tribal women has been identified from the locality and sent to Rajasthan for attending a five month long residential solar training programme prior to installation of the systems. They will look after the entire solar electrification work starting from installation to operation & maintenance of the entire project after coming back to Odisha after completion of the training programme.

### **Preparation of Village Disaster Management Plan**

Community participation and community ownership in disaster riskmanagement is one of the key factors in reducing vulnerabilities of people and minimizing disaster loss. Realizing the importance of community involvement in disaster management it has been decided to prepare Village Disaster Management Plan (VDMP) in the state by involving the respective communities of the village. The plan will address the preparedness, response and mitigation strategies developed by the community with well- defined roles and responsibility. The development of disaster management plan at the village level aims at building the capacity and resilience of the community to equip them with knowledge and skills so that management of various hazards becomes a way of life for them. The document will help the local community to prepare for, respond to and recover from any disaster effectively.

It was decided by the state government (OSDMA) to prepare the plan by the members of the Village Disaster Management Committee (VDMC) involving the community irrespective of class, creed, gender and occupational status, supported and facilitated by resource persons from NGOs, multi- lateral aid agencies and government officials. Agranee is one of the empaneled NGOs out of 19 selected by the District Disaster Management Authority (DDMA) Mayurbhanj to undertake the assignment as a facilitating/resource agency. Agranee has been assigned a total of 30 villages come under 03 Gram Panchyats of Kaptipada block, Mayurbhanj for this purpose and field level activities has already been initiated as per the signed MoU with DDMA, Mayurbhanj.
